CATU Ireland	Ireland	20000	The cost of living - especially unaffordable rents - coupled with insecure housing conditions are some of the main causes for economic insecurity which often relate to voting for protest or right-wing parties. CATU is a grassroots organisation in Ireland which fights alongside its members to win changes in their everyday lives in housing, the provision of community services, council maintenance and the usage of public spaces. Addressing tenants as political subjects, they think that collective organising, not extreme voting behaviour, can provide solutions to people's problems and build the political muscle in the long run.
Centro Educacion Popular Lohana Berkins	Germany	20000	A center for popular education in Berlin, Germany based on the principles of the "Pedagogy of the Oppressed" that does community organising with the Latin American community of the city. Developed by Latin American migrants, this crew wants to build a bridge that brings successful experiences and learnings from organizing in Latin America to Germany. Educación Popular is one of the most important contributions of the Latin American left to the repertoire of emancipatory praxis, however it is not so known in Germany. They wish to bring their expertise in this rich tradition and adapt it to fit the needs of local struggles.

They are a part of the Transnational Social Strike network, another 2023 Guerrilla grantee connecting these local experiences. Hosted by ATROCLA Associazione di Promozione Sociale.
Deviszont Community Space	Hungary	16000	A critical pedagogical initiative in the outskirts of Budapest, Hungary, with the aim of democratising access to political education and organising skills for working-class and Rom*nja young adults. The goal of the initiative is to achieve greater participation of Rom*nja youth in the often elitist and upper middle class social movement landscape.

ELSC European Legal Support Center	Netherlands	20000	The first and only independent organisation defending and empowering the Palestine solidarity movement in Europe through legal means. They provide free legal advice and assistance to associations, human rights NGOs, groups and individuals advocating for Palestinian rights in Europe and the United Kingdom.
Emergent Justice Collective	Netherlands	15000	Organisation that nurtures the emergent counterculture to dominant practices in the international justice space. Acknowledging that international law and lawyering culture is rooted in coloniality and that this community of practice is dominated by white supremacy, their vision is to counter these practices in both the substance of their work and the manner in which they engage with each other by embracing embodied, community-led and transformative liberatory lawyering practices. Hence they collaboratively pursue strategies, including legal interventions, to further structural change of oppressive systems at the root of global injustice using intersectionality and transformative justice.

Fantapolitica	Italy	14000	<p>A youth organisation in Italy whose goal is to accompany, facilitate and educate a network of young leftist local councillors and candidates so that they become the bearers of innovative methods and radical change in their communities, in their lists, and finally in the institutions, once elected.</p>

Gegužės 1-osios profesinė sąjunga - (G1PS)	Lithuania	40000	May 1st Labour Union (Lithuanian acronym G1PS) stems from a solidarity network led by a group of grassroots labour and feminist activists in Lithuania. Today it undertakes political action that promotes ideas of workplace democracy, sustainable economy and solidarity, especially in sectors with no union representation and with precarious work conditions, thereby focusing on migrant workers.
Genova Che Osa	Italy	20000	A grassroots organisation that acts locally in Genova using social municipalism to talk about and advocate for greater equality and solidarity in Genova. Their long-term aim is to affect change in their city on the institutional level, and their way of contributing to it is by organising mass mobilisation and direct action campaigns to create a new progressive culture for the city that ushers in an egalitarian, cooperative, non-hierarchical, inclusive, and democratic system.

Hellenic League for Human Rights (HLHR)	Greece	20000	<p>The oldest human rights organisation in Greece (founded in 1953). The League works on advocacy and the development of guidelines that relate to human rights and freedoms, particularly in the migration and asylum seeking sector. To uplift the rights of People on the Move, they work on topics such as the justice and the penitentiary system, police arbitrariness, religious freedom, racism and hate speech and freedom of expression.</p>
Kopacze Diggers	Poland	20000	<p>A collective from Warsaw, Poland that was established by and for women and queer people that built a space that provides a safety net for their community - a place to reflect, organise and take care of each other. Their space is open to small collectives and initiatives for meetings and to work on joint-strategies to uplift the rights of the LGBTQ+ and women in Poland.</p>

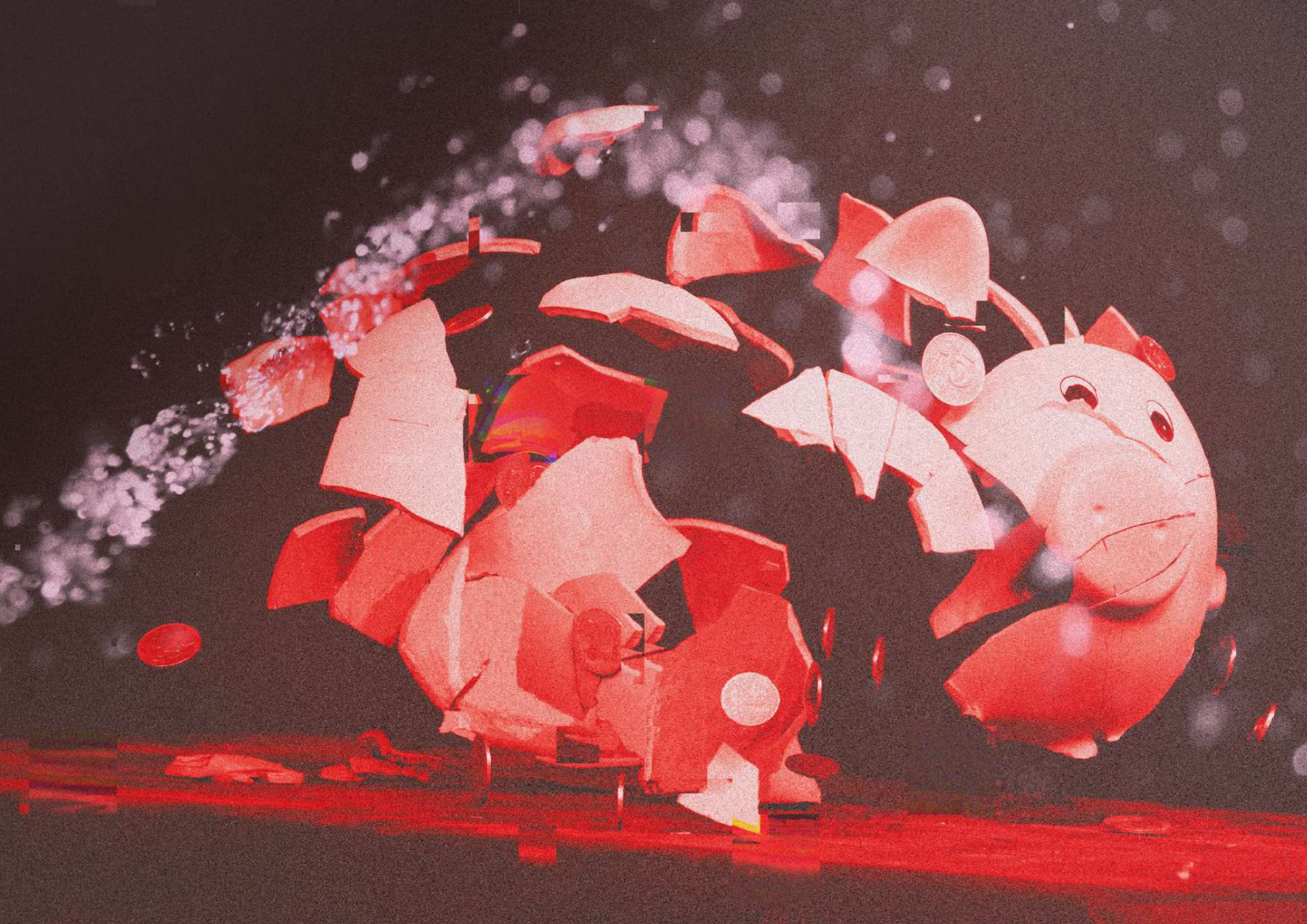

They aim to build a hub for social and climate justice movements as well as the local population to learn from each other and cross-pollinate social and local solutions for movements to thrive on a damaged planet.
La Foresta - accademia di comunità	Italy	19000	A co-housing project and activist space based on the principles of common good and inspired by the long history of the commons in Italy. Comprising several members of collectives engaged on social and environmental issues, La Foresta is a community resource for activism, working towards building creative and effective modes of practice and resources that support ecological and social justice.

The space is available to hundreds of people from groups and nourishes a wide range of contemporary creation projects for the public good. Hosted by Association Independent Cultural Scene of Serbia.
Mašina	Serbia	20000	A Serbian media portal that writes about labor rights, labor struggles and social movements from Serbia and beyond. This crew wants to lift perspectives from the left, especially considering that mainstream media are controlled by the state in Serbia, contributing with a critical approach to topics often neglected or treated from a conservative perspective concerning themes like: economy, ecology, degrowth, housing and gentrification, social services, participatory democracy and the democratic transition.

Standing up in defence of the territory and against the separation and destruction of the landscape and local communities, this group targets the state and the multinationals who are responsible for advancing big-mining projects, their political lobbying and the compliance of the institutions.</p>
<p><u>BARAC</u></p>	<p>UK</p>	<p>3000</p>	<p>A grassroots organisation campaigning against racial injustice at its intersections with austerity, enshrined institutional racism (from criminal justice to policing to education systems), migrant/refugee rights and climate justice. Some of the things that this group rises against are the injustices felt by black communities in employment, education, service provision, racist immigration policies, climate displacement, humanitarian aid and solidarity missions to support people who are refugees and those with no recourse to public funds.</p>

Communitism also supports and works with the neighborhood they are in, with the aim of preserving the building for commoning and to counter the ongoing gentrification of Athens

Deviszont Community Space	Hungary	5000	A critical pedagogical initiative in the outskirts of Budapest, Hungary, with the aim of democratising access to political education and organising skills for working-class and Rom*nja young adults. The goal of the initiative is to achieve greater participation of Rom*nja youth in the often elitist and upper middle class social movement landscape.
Eco-Social Movement of Exarheia Square	Greece	9000	A grassroots organization comprised of cultural workers, artists and architects/engineers engaged in raising awareness and legal challenges to the state. Their main concern is the police occupation of Exarchia Square and the gentrification of this historic neighborhood which has been a center for liberatory movements for half a century. They sued the municipality in an effort to halt the destruction of green spaces and force the city to study the environmental impact of new construction projects, as is required by law. They've created a public information campaign to investigate the impact of private investment in this area of town and its effects on gentrification and the health of their community.

Gaudenzdorfer Gürtel, Rote Hilfe Regionalgruppe Wien	Austria	7500	A group of activists and tenants who fight against the myth of the „Red Vienna“. The housing and living costs in this city have been increasing for years and continue to do so. The commodification of housing leads to precarious situations where evictions are only the tip of the iceberg while there's many other systemic issues going upstream. In response, this group combats real estate companies, educates the public and organizes city-wide protests. Hosted by Rote Hilfe Regionalgruppe Wien
German Brumadinho litigation - c/o Legal Leverage Platform e.V.	Germany	8000	A team of German lawyers working pro bono for the relatives of the victims of the Brumadinho disaster, where on January 25th 2019, a dam bursted and almost 270 persons were killed. The dam had been operated by Vale (a big mining company) in Brumadinho/Brazil. It had been certified as safe by the German TÜV SÜD, despite ample evidence pointing to the contrary. HuBB - Humans Before Borders	Portugal	6500	A collective based in Lisbon and Porto run by a group of activists working towards a world where refugees' and migrants' rights are fulfilled. Since 2018, they have advocated and campaigned for human rights, demanding the protection of migrants and raising awareness among civil society. To make this a reality, they create petitions, put together gatherings and protests, organize movie screenings, talks and festivals.

ISKS pursues abolitionist visions akin to those dreamed up and popularised by Black, queer, radical feminist thinkers in North America. This means not only removing police, but replacing them with a radically transformed system of justice: a system in which social problems are treated with social solutions; in which everyone, regardless of background, receives the care they need. <u>Institute of Radical Imagination - IRI</u>	Italy	9000	An assembly of 17 activists from different activist organisations with a common mandate to work towards post-capitalist realities by means of the legal recognition of the commons, radical pedagogy, work and labour commoning, rethinking citizenship, spatial justice and the architecture of the commons, and exploring non-hegemonic economic models.
Inter Mutuelles LGBTQI+	France	1500	With the cost of living crisis reaching unprecedented scale in Europe, an informal and self-led LGBTQ+ group started to self-organise locally to allocate a part of each group members' monthly income to mutual aid, supporting those facing increased financial difficulty and those hit by economic injustice within the LGBTQ community. There are about 20 of such groups with 15 to 25 members spread across France.

Le Next Level	France	7500	Collective supporting and developing projects for social and racial justice by way of community organising, training, consulting and coaching for both those with lived experience of marginalisation as well as those in positions of power who want to build empathy and courage-based leadership structures that fight oppressive systems.

Georgia	9000	A decade-old collective of radicals from Eastern Europe and other parts of the world whose main line of activity is writing, soliciting, translating, and editing articles that analyse the workings of neoliberalism and supporting anti-capitalist, ecological, feminist, and anti-racist social movements in the postsocialist world.

Observatorio Trabajo Algoritmo y Sociedad (Riders x Derechos - Elite Taxi)	Spain	5000	A non-profit association born from the convergence of members from Élite Taxi Barcelona, Riders x Derechos and independent technicians who work to defend the interests and rights of workers in the gig economy. Our funding allowed the group to continue a legal fight against Glovo, one of the biggest Spanish delivery platforms.
