ORGANISATION	COUNTRY	GRANT AMOUNT	DESCRIPTION
ALDA	France	20000	ALDA is a grassroots organisation based in the French Basque Country which aims to defend working-class people's rights to organise communities and to react to the ecological and social metamorphosis of the territory. It works to support low-income neighbours affected by problems related with touristification and the increase of the cost of living in this region of France. ALDA creates activities that bring radical politics to the neighbourhood, a frontline struggle where residents' are the frontrunners addressing the root causes of these problems through community-organising and campaigning.
Atelier Autonome d'Enquete et de Formation Populaires (AAEFP)	France	20000	Founded in 2017 in Toulouse, AAEFP is a popular education collective that wants to ignite critical self-thought rooted in struggles against poor housing, precarity and state violence. This grant went to support the work on their current project Global War Against the Peoples where they covered the inherent costs of producing the film, the digital platform where it will be showcased and related training workshops that empower grassroots resistance to the global war and surveillance industries.

Blackn[è]ss Fest	Italy	20000	Blackn[è]ss Fest is a three-day event taking place in Milan since 2021. It aims to normalise and spread conversations about the racist nature of our dominant systems. Next to the festival, this crew works on a podcast where they spotlight stories of racialised people, highlighting the complexity of individual experiences of PoCs in racist and xenophic Italian mainstream society.
Bloque Latinoamericano	Germany	16000	Bloque Latinoamericano is building a European network of grassroots organisations in solidarity with resistance movements across Latin America, aiming to strengthen global opposition from below against the rise of right-wing forces. The European frontline builds on the existing work of the “Argentina Is Not for Sale” network, a coordination of groups in over 20 cities formed in response to the first measures of the Javier Milei government of Argentina.
CK13	Serbia	20000	The youth center CK13 is a well established independent social and cultural center in Novi Sad, Serbia. It is organised by local enthusiasts and activists, with the aim to strengthen political self-consciousness, self-organising and social and cultural engagement of citizens, youth in particular, through organising a continuous multifaceted program of political, activist, educational, cultural, and artistic activities designed towards personal and social emancipation. Being both a community and a public space, CK13 also holds a unique position as a pivotal meeting point, and a resource center providing space and resources for nonformal collectives, civil society organisations, initiatives and self-organised citizens in Novi Sad and beyond.

<u>CLE Autistes</u>	France	20000	CLE Autistes is an autistic-led collective advocating for the rights, autonomy and full social participation of autistic and neurodivergent people in France. Rooted in the neurodiversity movement and a political vision of disability, they challenge ableism and saneism through mutual support, advocacy and education. This grant supports their Autistic Leadership Project, including the hiring of a part-time community organiser, the launch of educational workshops and camps, and the expansion of support groups, campaigns and public actions focused on healthcare, independent living and participatory research.
<u>Common Ecologies School</u>	Austria	20000	Common Ecologies is a movement school without walls that works across contexts. They organise courses, discussions, encounters, co-research and learning processes and programmes and make podcasts and publications. This grant helped take the movement school to a next level, making work more sustainable, and finding ways of expanding it strategically. The money will also cover a retreat, an annual network gathering and will consolidate the collaborations that are at the bedrock of this movement.

<u>Common Thing Foundation - Fundacja Rzecz Spoleczna</u>	Poland	20000	The Common Thing Foundation uses community organising to build collective power and address systemic injustices at the grassroots level. Their recent “Blooming Silesia” campaign brings together a broad coalition of women-led groups, climate activists and local communities to protect urban green spaces in Silesia: a region at the heart of Poland’s coal industry. The campaign challenges unchecked development, advocates for just and sustainable urban planning, and strengthens civic participation across political divides. Through education-in-action and networked organizing, the foundation is equipping residents with the tools to demand climate justice, democratic transparency and long-term systemic change.
<u>Communitism</u>	Greece	20000	Communitism is a team of artists, cultural managers, architects and restoration engineers who negotiate the occupation and use of abandoned heritage properties to house creative professionals and communities for little or no rent, in return for them using their presence, skills, energy and enthusiasm to preserve and restore Athens’ abandoned heritage buildings through a process of creative commoning. Next to the restoration costs for a permanent ‘home’ that is being built, extensive networking and programming, this crew is working on a model that can “infectiously inspire” communities to take action. This grant went to support their ongoing activities and also to popularise the collective ownership and management model of the space.

Conscientious Objection Watch (COW)	Turkey	20000	Contentious Objectors are criminalised as evaders in Turkey. Next to defamation, people who reject to do obligatory military service face heavy prison sentences, criminal cases or fines. Contentious Objection Watch is working on furthering the right to conscientious objection that has not yet been recognised in Turkey, namely doing consultations with conscientious objectors, supporting them with litigation, as well as doing advocacy work in and outside of Turkey.
CopWatchGR	Greece	20000	CopWatchGR, launched in November 2020, is Greece's first network dedicated to monitoring police violence and arbitrary actions. It documents incidents such as racial and gender-based violence, repression of social movements, and police corruption, while providing tools for citizen self-defense, legal education, and collective memory and fostering collaboration with like-minded groups in Greece and beyond. This grant went to support their ongoing activities.
Enmedio	Spain	20000	Enmedio is an activist collective resisting a speculative urban development plan (PDU3X) that would construct 1,844 homes in a flood-prone area of the Barcelona metropolitan region, already impacted by severe coastal erosion. With this grant they organised public meetings, conducted research, and carried out actions to expose the environmental risks posed by the project. A press and social media campaign will further raise awareness and mobilise public support to halt the development of this contentious construction project.

European Council for Autistic People (EUCAP)	Czech Republic	20000	EUCAP serves autistic-led organisations across Europe, supporting them in their advocacy work and project initiatives in Europe and beyond. EUCAP gives voice to autistic people who face poverty & exclusion, and ask questions that are not generally asked in autism research, or in advocacy led primarily by non-autistic parents and professionals. This grant went to support their ongoing activities.
Forensic Architecture Initiative Athens (FAIA)	Greece	20000	Forensic Architecture Initiative Athens conducts spatial, visual and multimedia investigations into state violence, environmental harm and human-rights abuses, pioneering new evidentiary techniques and open-verification frameworks. With a core funding grant, FAIA will build foundational capacity for research-led casework and carry out community outreach to document instances of civil dissent
FundAction	Netherlands	30000	FundAction is an activist-led participatory grantmaking fund that Guerrilla helped set up. They shift decision-making power over funding from funders to affected communities and activists working on the frontlines. FundAction brings together a growing community of grassroots activists across Europe who decide together what gets funded. This was a solidarity grant to this fellow participatory grantmaker so that they can keep doing radical, community-oriented funding.

<u>Human Conet</u> = <u>Juntos Somos</u>	France	20000	Human Conet – Juntos Somos strengthens grassroots networks to coordinate campaigns and disruptive actions that promote corporate accountability and environmental justice across Europe in response to violations of human and environmental rights in Colombia. This grant supports key activities aimed at promoting corporate accountability and environmental justice across Europe but with a particular focus on France. Namely it helps establishing a European coordination team that will organise direct disruptive actions and campaigns. This team will work closely with the Colombian office, and through them, with indigenous, Afro-descendant, and rural communities affected by environmental degradation caused by European corporations.
<u>INDEX</u>	France	15000	INDEX is the only independent structure in France offering counter-investigation services to victims of police violence. This grant funded the production of 3 to 5 expert reports, free of charge for victims or their families, enabling INDEX to meet growing demand and support urgent cases that would otherwise go unanswered due to limited resources. This gives them leeway to work more strategically in not only publishing these reports but also producing the backbone investigation that lays the groundwork to pressure the French authorities about the urgency of addressing police impunity in France.

<u>International Women* in Space</u>	Germany	20000	International Women* Space (IW*S) is a self-organised feminist, anti-racist group based in Berlin that is refugee and migrant-led. They work to highlight the complex intersecting layers of oppression that refugee and migrant women* experience due to their gender, race, abilities, nationality, and migration status in and beyond Berlin. They do outreach workshops in Brandenburg where they are closer to the Lagers (temporary refugee housing facilities). IWS are empowering refugee and migrant women by sharing knowledge and inviting experts to consult them on relevant topics (e.g. legal advice, physical and psychological health, education, intersectional discrimination in the German asylum system, decolonisation and climate justice). Their work facilitates powerful peer to peer learning and the creation of support structures. This grant went to core funding to support their ongoing activities.
<u>Kazán Community House (Alliance for Collaborative Real Estate Development)</u>	Hungary	20000	Kazán Community House (Alliance for Collaborative Action) is a grassroots hub in Budapest's 8th district hosting political education, media labs and movement gatherings for working-class and marginalised communities who live in the area. This grant went into core funding, campaigning and community outreach for their program "From Neighbourhood to Community" that invited impacted communities to come together and build shared resistance around the issues they have in common.

Klara i Rosa	Serbia	20000	Klara i Rosa is situated in the city of Subotica, in the north of Serbia bordering with Hungary. The organisation aims to bring the polarised multi-ethnic and mutli-lingual city together by organising programs that inspire dialogue and enhance civic pariticipation in a pretty neglected area of the country. Their physical space is meant for community-building, hosting a variety of cultural programs and critical education workshops that engage residents to blend beyond perceived difference. The grant supports their programmatic activities, covering costs such as renting the house where their civic community center is located, utility expenses, salaries, and investments in equipment and improving the space in which they work.
Kopacze Diggers	Poland	20000	Kopacze Diggers want to see the emotional and physical health of fellow activists and those who are oppressed by systemic injustices taken care of. That means giving space to rest, recovery, joy and pleasure in addition to the very valuable and important work that visiting collectives do in their fields. For that their building in rural Poland needs renovation and some innovations to make the place more accessible, useful and cosier so people could use it comfortably for retreats and unlearning of capitalist patterns.

<u>Medico international</u>	Palestinian Territories	36500	Medico International fiscally hosted the Culture and Free Thought Association (CFTA), a very important actor for the civil society in Palestine. Founded in 1991, it is one of Gaza’s largest and most active human rights networks, providing both development and emergency humanitarian support. For over 30 years, it has created safe, interactive spaces in central and southern Gaza to foster learning, skill-building, and community connection. This grant went to support their ongoing activities.
<u>National assembly of working-class neighbourhoods (NAWCN)</u>	France	15000	The National Assembly of Working-Class Neighborhoods (NAWCN) is a collective of residents, artists and activists engaged in struggles against police violence, systemic racism, labor precarity and social exclusion. Formed to build political power from the ground up, they aim to develop a grassroots narrative of life in working-class neighbourhoods and support the emergence of local leaders—empowering them to train others and run for office in future elections.
<u>New visions e.V.</u>	Germany	20000	A feminist and queer-led cultural grassroots organisation bringing together activists from Eastern Europe. This grant supports the redesign of the TAIGA program into a complex, hybrid offering aimed at empowering movements in Eastern Europe. The curriculum, developed in dialogue with local and diasporic communities, union organisers, migrants, refugees and frontline workers, builds on Ulex’s tools for transformative collaboration, movement ecology and regenerative activism while infusing it with New Visions’ own artistic and unconventional twist: a magical, witchy, somatic approach rooted in mutual aid, herbalism and ancestral knowledge from the region.

<u>Peoples Health Hearing Collective</u>	UK	20000	The People’s Health Hearing Collective works to build a global movement for reparative health and environmental justice, rooted in deep trust, solidarity, and resistance to extractive systems. Their work centres the perspectives of Global Majority communities, focusing on reparations and systemic change in North–South economic and environmental relations. This grant supports an internationalist campaign targeting Shell, building on the verdict of the People’s Health Tribunal and advancing the collective’s broader vision through cross-border exchanges, local community projects, and solidarity-based tribunals.
<u>Platzforma</u>	Moldova	20000	Providing legal support and protection to workers from Floreana Fashion, a former textile factory in Cupcini (Moldova) who are entering legal proceedings for unpaid wages. This grant will provide legal assistance and fund a media campaign to help and inspire other workers that are in a similar situation to act and fight for their rights.
<u>Polen Ekoloji Kolektifi</u>	Turkey	20000	Polen Ekoloji Kolektifi is creating a Marxist ecology institute that links class struggle with climate justice and anti-extractivism in Turkey. This grant underwrites foundational research, popular education and movement infrastructure so that eco-socialist analysis and organising tools are produced by and for grassroots activists.

Porco Rosso	Italy	15000	Porco Rosso is a community center in Palermo, Sicily, that is strongly rooted in the local community, while also part of the national membership network ARCI . They serve as an activist center, cultural hub and legal advice point for people from a range of backgrounds, stories and journeys. Next to their central activity - the 'Sans Papiers' weekly drop-in, which is providing free legal support and service signposting to migrants and locals - this grant contributes to monitoring arrests of people on the move and outreach to migrant arrestees. They aim to engage Italian journalists who can bring a critical perspective to reporting on the criminalisation of migration to the media landscape.
School of Public Life	Hungary	20000	The School of Public Life is a grassroots education center supporting social justice movements through political education and training. With this grant, they will deliver 10 workshops and a 6-day critical pedagogy course, and publish two activist handbooks - one on grassroots organising, and another on running community-based local election campaigns.

<u>Siddetsizlik Merkezi - Nonviolence Center</u>	Turkey	19000	This cre is supporting feminist and LGBTQI+ activists through organisational re-structuring around nonviolent action & organising. That involves activities like nonviolent-action trainings, upskilling members in consensus-based decision-making as well as organisational wellbeing. This core funding grant will allow them to scale up training modules, involve more organisations in the trainings and amplify advocacy for NVC work within turkish grassroots ecosystems.
<u>Solidaria Association</u>	Italy	20000	Solidaria drives feminist, migrant and ecological organising in Sicily, building power through participatory workshops, public actions and mutual aid. The grant fuels a new campaign cycle: resourcing grassroots pilot programs on agroecology and migrant justice, and amplifying them through community media and street mobilisations.
<u>Supporting Abortions for Everyone (SAFE)</u>	Netherlands	20000	SAFE is a group that exists to support the grassroots activists helping people get abortions across Europe. These small, underfunded groups ensure reproductive justice by helping some of the most disenfranchised people get abortions when draconian laws are at play or/and when the state fails them. While they do the frontline work, SAFE underpins their efforts with admin, fundraising, knowledge curation, and training, for which this grant was used.

<u>The Class Work Project</u>	UK	20000	The Class Work Project is a workers' co-operative developing theory, analysis and practice around class identity, oppression and stigma in Britain and beyond. They centre poor and working-class voices through Lumpen (their journal), art, education and the "Exploring Class" workshops that are tailored for movements to emphasise class perspectives. This grant funds a new workshop on the intersections of migration and class, including three public pilot sessions and a full roll-out so groups can better recognise prejudice and organise more inclusively.
<u>Trans Mreža Balkan</u>	Croatia	20000	Trans Mreža Balkan works to strengthen a regional transfeminist movement across the Balkans by supporting trans, intersex and gender-variant communities to engage in broader social justice struggles. Their work challenges oppression based on gender, class, race and other intersecting forms of marginalisation, while also focusing on strategic communications to counter anti-gender narratives and promote a bold transfeminist alternative. With continued political turmoil in the region, the movement sought core funding to further embed the voices of their regional network into the ongoing national struggles in Montenegro, Serbia and Macedonia.

Turning Point	Italy	20000	Turning Point is an new in-depth online magazine that provides alternative views and fresh perspectives to read the world. The magazine is made by and for those seeking to change the system. Far from click-baiting and breaking news trends, they want to offer critical long-term analyses and aim to reshape the dominant narrative by amplifying diverse movements, communities, their respective struggles, and outlooks. As they say, if media can't be objective, it can be truthful.
Un Tetto Sulla Testa	Italy	20000	Un Tetto Sulla Testa (A roof over head) is working to provide accessible and dignified housing for all. The project responds to the stark gentrification felt in Florence by building commons and housing for communities in need, activist gatherings and organising for the right to housing & the city in Florence and in its suburbs. This grant went to support their ongoing activities.
We Are the Resistance	Spain	20000	We Are the Resistance organizes the "Gender Justice in the Fields" camp to bring together activists, farmworkers and scholars for trainings on gender, labor and agro-ecology. With this grant they will expand camp programming, deepen partnerships with grassroots networks and develop digital toolkits for future cohorts.

ORGANISATION	COUNTRY	GRANT AMOUNT	DESCRIPTION
<u>Associação Observatório dos Recursos Naturais (ORN)</u>	Portugal	8000	This volunteer collective documents mining's social and ecological impacts and supports anti-extractivist organising across Portugal, particularly against lithium projects framed as "green". They gather data, train communities and link local fights to global struggles against resource exploitation. The grant funds documentation for MINOB and an anti-extractivism summer school to build skills and alliances that further their research and documentation of the struggle.
<u>Associação Unidos em Defesa de Covas do Barroso (UDCB)</u>	Portugal	8000	UDCB defends the Barroso region from extractivist mining projects and protects its agro-ecological commons. They convene residents, farmers and activist allies to strategise, document impacts and mobilise resistance. This grant supports the 2024 Barroso Camp, bringing together local and international activists to plan actions, exchange knowledge and strengthen community defence.
<u>Association d'Accueil Agricole et Artisanale</u>	France	9000	This association supports undocumented agricultural and artisanal workers in Brittany with housing, legal aid and collective organising. By documenting lived realities and building solidarity, they push for migrant rights and regularisation. The grant went to help launch a multimedia platform to tell workers' stories and galvanise public support for their demands.

<u>BIPoC Climate Justice Conference</u>	Germany	5000	This network of BIPOC climate and social justice activists is spread across Europe, with members active in various migrant-led and BIPOC-only collectives within the broader climate justice movement. Though not a formal organisation, they collaborate across geographies to confront the racism, eurocentrism and colonial dynamics embedded in mainstream climate spaces. This grant supported their effort to organise a BIPOC-only climate justice conference in summer 2024, creating a space to share strategies, build solidarity, and reclaim climate justice as a decolonial and liberatory struggle.
<u>Blackn[è]ss Fest</u>	Italy	9000	Italian-based group organising the yearly Blackn[è]ss Fest - an event simultaneously celebrating Blackness and exposing how Black and PoC people are subjected to systemic discrimination in Italy. Through podcasts, workshops, performances and political education, the Blackn[è]ss Fest & podcast builds community power, the festival serving as a catalyser for the podcast held year-around. Core funding sustains programming and the collective labour needed to hold these activities.

<u>Ccà Nisciun' è Fessa</u>	Italy	8000	Ccà Nisciun' è Fessa is a feminist and pro-abortion collective in Naples organising for reproductive justice, gender self-determination and public healthcare in the face of stigma and institutional neglect. They are hosting a three-day festival to connect struggles across Italy and Europe, mobilise local communities and launch a campaign demanding access to abortion and public resources in southern Italy.
<u>Collective Humans Before Borders (HuBB)</u>	Portugal	6500	A collective of volunteers and activists in Portugal fighting for a world where refugees and migrants' rights are fulfilled. They advocate for human rights, refugees and asylum seekers protection and create direct actions like petitions, gatherings and protests. They also raise awareness through screening movies and hosting debates and talks. This grant supported the organisation of their yearly festival held in Lisbon where many migrants' associations, activists, collectives and state representatives convene, exchange and plot alliances for future actions and interventions.
<u>Conscientious Objection Watch (COW)</u>	Turkey	9000	COW defends the right to refuse compulsory military service in Turkey, where conscientious objectors are criminalised and harassed. They provide legal aid, public advocacy and international lobbying to challenge militarism and secure recognition of objection to military service as a human right. Core funding here went to support casework and campaigns that confront the state's punitive approach.

ORGANISATION	COUNTRY	GRANT AMOUNT	DESCRIPTION
CopWatchGR	Greece	5000	CopWatchGR monitors police violence, offers legal referrals and trains communities in self-defense against repression. The collective maintains a public reporting platform and builds networks of support for victims. Transitional funding keeps their core operations running during a internal structural change and ensures continuity of monitoring and advocacy.
Dár - Decolonial space in Prague	Czech Republic	9000	Dár is a new migrant-led collective creating a political and cultural space in Prague rooted in SWANA self-determination, decolonial practice and solidarity with Palestine. Support goes towards building the physical infrastructure of the space and resourcing the team as they launch their first phase of organising.
de:border // migration justice collective	the Netherlands	3000	de:border documents violent pushbacks and border militarisation in Greece while supporting people on the move. Their work exposes abuses and presses authorities for accountability. This urgent-action grant enables solidarity netowrk building by supporting costs for documentation, legal referrals and solidarity interventions for the groups they collaborate with to attend the European Court of Human Rights hearing on Greek pushbacks.

Dokustelle Österreich	Austria	8000	Initiated in 2014, Dokustelle reports incidents of anti-Muslim racism and captures with “statistics from below” the extent of anti-Muslim racism in Austria. Today their activities comprise documenting, monitoring and analysing incidences of Islamophobia and anti-Muslim racism, compiling info based on reported cases and presenting their findings. The grant was used to strengthen capacities of staff, students, scholars and artists working in educational institutions in Austria to counter repression of free speech and academic freedom - with a focus on the rights of Palestinians for an end to the war in Gaza, and for Palestine’s self-determination and freedom.
Dzikie Karpaty	Poland	8000	The Wild Carpathians Initiative defends old-growth forests in the Polish Carpathians, a large forrest that is highly targetted for logging. They do so through direct action, legal pressure and public campaigning. Activists monitor logging, occupy threatened areas and educate the public around climate and social justice using the forrest as their struggle. This grant went to core funding which keeps field teams equipped, strengthens legal efforts and coordinates volunteer infrastructure.
Ecologia Politica Network	Italy	9000	A network advancing radical ecological politics via local working groups, research and public education. They connect anti-extractivist, climate and social-justice struggles across Italy. The grant provides core support for local organising and a national assembly to align strategy and share tools.

<u>Féministes contre le cyberharcèlement</u>	France	9000	This feminist collective combats online abuse and gendered cyberviolence through advocacy, survivor support and legal strategy. They address a growing wave of digital attacks that silence marginalised voices. Core funding sustains their hotline, resource production and policy work, helping people to navigate hostile online environments that heighten cyberbullying.
<u>Frank Barat</u>	Belgium	6500	Frank Barat is an organiser and curator who builds platforms for Palestinian voices when mainstream outlets silence them. He convenes events, publications and campaigns that connect the pro-Palestinian movement across borders and deepen a culture of solidarity. This grant supports Voices for Gaza, a project spotlighting personal testimonies of the suffering from people in Gaza - read out loud by public personas to expand the reach of these stories and mobilise people for the cause.
Free Black Tunisia Group	Germany	3000	Free Black Tunisia Group organises against anti-Black racism and state violence targeting Black Tunisians at home and in the diaspora. They organise protests, amplify testimonies and build alliances across borders. The grant backed their May action in Berlin and related organising, strengthening transnational visibility for Black Tunisian struggles at the heart of Europe.
