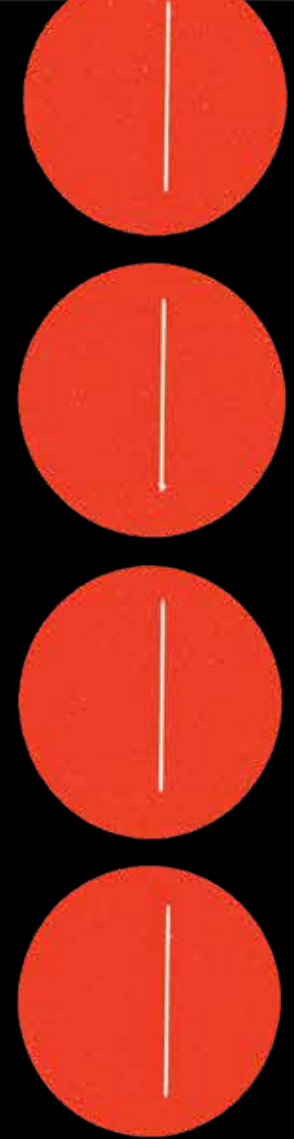

Action Grant Table

Organisation	Grant amount	Country	Description
<i>*in our bodies - on the streets*</i>	20000	<i>Central & Eastern Europe</i>	A transnational collective of somatics practitioners bringing generative, politicized somatics to activists in the regions of Central and Eastern Europe and the Caucasus. Politicized somatics is an approach to healing and transformation that acknowledges the interconnectedness of personal and collective healing and well-being, recognizing how we are part of creating the societal conditions that can imbue systems that step out of the logics of disconnection from self and others. This grant provided core funding for the organisation.
<u>Trans Mreža Balkan</u>	20000	<i>Croatia</i>	A transfeminist network by and for trans, intersex, and gender-variant people and organizations from the Balkans. Besides promoting regional connection and exchange, Trans Mreža Balkan is concerned about the role of strategic communications to counter media corruption in the mainstream. Because of continued political turmoil in the region, the movement received core funding to further embed the voices of their regional network into the ongoing national struggles in Montenegro, Serbia and Macedonia.
<u>re-set</u>	20000	<i>Czech Republic</i>	A platform run by movement organisers in the Czech Republic that facilitates a space for grassroots actors to think about their long-term political strategies. Historically, Re-set stemmed from housing rights organising, but they have evolved into wider movement building work. This grant specifically went to support local tenants movements across Czech Republic harness their political power.
European Jews for Palestine (EJP)	20000	<i>Denmark</i>	A grassroots European network of 27 member organisations across 17 countries, operating as an umbrella body that coordinates anti-Zionist Jewish organising while challenging Zionist institutions' monopoly on Jewish life and politics in Europe. They organise monthly meetings to plan and coordinate their activities, which are built around ending European complicity with Israeli occupation, apartheid, and genocide. They push for measures such as an arms embargo and the scrapping of the IHRA definition of antisemitism, while also fighting the repression of pro-Palestine dissent across Europe. The grant went into supporting their ongoing work.

Ellos Deatnu! [Long Live Deatnu!]	20000	<i>Finland</i>	A group organising around decolonisation and self-determination of Sámi people and their stewardship capacity of the river Deatnu. This grant supports community-led knowledge-sharing spaces and land-based interventions that strengthen Sámi communities' role in protecting their territories and responding to the river's rapidly changing natural and social ecosystems.
Collectif #EcolePourTous	20000	<i>France</i>	An organisation fighting for equal access to education for children and young people in France who are excluded or marginalised because of extreme poverty, nationality, or ethnic minority status. They believe that the right to education is essential for long lasting social change so they target people who have experienced violations of the fundamental right to education to prepare the next generation of critical thinkers and doers. They thereby develop strategic campaigns and work closely with schools and other institutions to bring changes that empower youths directly. This grant provides core funding to carry out this work.
Histoires Crépues	20000	<i>France</i>	A French anti-racist media association founded in 2020 by video artist and journalist Seumboy Vrainom, and now one of the largest anti-racism channels in the French-speaking world with over 900,000 subscribers. This grant supports their production of videos, documentaries, and broadcasts that analyse current events through a decolonial lens and challenge far-right narratives in French public debate.
Strong Wings (Sudfa Media)	20000	<i>France</i>	"Echoes of the sudanese revolution" can be seen written on their social media and couldn't describe the group better. This collective was founded by Sudanese and French activists who met during the 2019 Sudanese revolution in Lyon. It was created to raise awareness about Sudanese history, society, and its revolutionary movement. Their work centres on amplifying the voices of Sudanese grassroots resistance committees and exiled activists - telling their stories in their own terms-, by translating Arabic texts into French, organising public events across Europe and Africa, and building transnational solidarity networks that challenge dominant media narratives and counter the under-representation of Sudan's war and democratic struggles. This grant supports their work amplifying the voices of Sudanese civil society through translation, public events, and transnational solidarity networks.

<u>Les Voix Eclairées</u>	20000	France	A collective founded in 2023 in Joigny, a rural area of France, bringing together fifteen women directly affected by the oppressions they fight with the aim of connecting feminist and anti-racist struggles in rural territories where these issues are often invisible. They run monthly workshops against discrimination, perform participatory lectures that blend personal storytelling with political analysis and build community in the periphery. Les Voix Eclairées creates opportunities for healing, skill-sharing, and collective organising rooted in the belief that rural areas are also (if not more) important places to fight systemic oppression. This grant provides core funding to carry out this work.
<u>Collectif Sensé</u>	20000	France	A grassroots group created by exiled people and former social workers with the aim of building a horizontal, militant, self-managed space in Marseille. Created by and for racialised and undocumented people, their space serves as a movement hub where different collectives converge. It allows members to organise, exchange ideas and build lasting solidarity via cultural workshops, trainings on legal rights and access services for exiled people — mostly women who are victims of violence. The space also enhances gift economy practices amongst activists and functions as a safe port for those in extremely precarious situations to meet and rest.
<u>La Bléd association (Yakoua Collective)</u>	20000	France	YAKOUA is an international collective of QBiPoC feminist self-defence trainers working for gender and racial justice based in France, Belgium and Switzerland. They tailor feminist self-defense practices for a racialised audience and lead a network of mutual support, enabling trainers and practitioners to share experiences, tools and resources around bodily autonomy, self-preservation and social justice. This grant went into core funding for collective to unite, train and develop a course for women and queer people experiencing racism on a daily basis.
<u>Tant que je serai noire (TQJSN) (As Long As I Am Black)</u>	20000	France	A grassroots, afrofeminist media and community organization based in France. Founded in 2020, Tant Que Je Serai Noire (As Long As I Am Black) advocates for reproductive justice, centering the experiences of Black women and gender minorities across the French-speaking world. They use cultural production (podcasts, events, publications) and community organizing to address systemic racism in healthcare, reproductive oppression, and gendered violence. This grant went to sustain and scale their political education, community organizing, and narrative change work.

<u>IWS - International Women* Space</u>	20000	Germany	A self-organised feminist, anti-racist group based in Berlin that is refugee and migrant-led. They work to highlight the complex intersecting layers of oppression that refugee and migrant women* experience due to their gender, race, abilities, nationality, and migration status in Berlin and Brandenburg. They do outreach workshops in Brandenburg where they are closer to the Lagers (refugee temporary housing facilities). Besides, IW*S empowers refugee and migrant women by sharing knowledge and ideas and inviting experts on relevant topics for ongoing peer to peer learning and support structures. This grant provides a continuation of core funding for IW*S.
<u>Bodywork Community Salon</u>	20000	Germany	A weekly initiative that provides access to free bodywork, somatic trauma therapy, herbal medicine, community ear acupuncture (NADA), and tool-sharing workshops for Palestinians, BIPOC, allies, and activists in Berlin. Their work supports those affected by the ongoing genocide in Gaza, the broader political climate in the Levant region, and the increasing state repression within Germany. With this grant they want to build up a Scholarship program to make bodywork education accessible for Palestinians and Arabic-speaking individuals in Berlin.
<u>The Black Sex Worker Collective BERLIN (THE BSWC- BERLIN gUG)</u>	20000	Germany	A collective based in Berlin that seeks to amplify the voices of Black sex workers by doing political service provision and community organising. The work entails peer support, legal assistance, housing, and other basic needs. Their goal is to create a safe space where the unique experiences and needs of current and former Black sex workers are validated and responded to with appropriate, resource-based support. The organisation emphasises the importance of centring the specific realities of Black people within broader sex work visibilisation and political subjectivity. The grant went into securing essential equipment, complete necessary upgrades, cover rent, leadership stipends, and strengthen their infrastructure through transformative programming and base building.

WE AID gGmbH (Global Asylum Seeker Human Rights Defenders Committee GASHDC)	20000	Germany	A radical social justice movement in Germany founded and led by exiled human rights defenders who have themselves endured torture and imprisonment, positioning asylum seekers at the forefront of demanding accountability and systemic change around inhumane migration policies in Europe. This grant supports their frontline work pushing for genuine protection of asylum seekers, to upend inhuman treatment of refugees and promote dignified life and treatment for people on the move.
welcome united	15000	Germany	A transnational network of self-organised migrant justice and anti-racist groups working through practical solidarity, political resistance against border regimes, and cross-movement connection. This grant covers visas, travel, food, and translation for their Transborder Summercamp 2025 — a space for exchange, skill-sharing, and network-building, ensuring people from the Global South and those without resources can participate fully.
Sudan uprising	20000	Germany	An informal collective and political platform, founded by Sudanese diaspora and Sudanese-German activists in Germany at the beginning of the Sudanese Revolution (2018-2019). It was born to support the uprising in Sudan with a special focus on migration and EU migration policy. SUG is also working in alliances and networks from the Global South in Germany, fighting for the freedom of movement and acting as a voice of the so-called voiceless people. The grant supported their efforts towards building a democratic left-wing alliance of exiled Sudanese people in Europe.
KriSol c/o Prof. Dr. Robin Celikates FU Berlin, Institute for Philosophy	20000	Germany	A platform by and for people working in universities, research, and cultural institutions in Berlin, developing infrastructure to protect academic freedom and university autonomy. The alliance wants to create a network of solidarity that leaves room for the heterogeneity of political positions as well as for the diverse cultures of different fields of study. By giving critical scholarships and creating programs, they resist against the securitization of universities, discrediting of empirical knowledge, and exclusion of marginalised groups from academic life. This grant went to fund their ongoing work.

ELLINIKI ENOSI GIA TA DIKAIOMATA TOU ANTHROPOU (Golden Dawn Watch)	20000	Greece	A radical social justice movement in Germany founded and led by exiled human rights defenders who have themselves endured torture and imprisonment, positioning asylum seekers at the forefront of demanding accountability and systemic change around inhumane migration policies in Europe. This grant supports their frontline work pushing for genuine protection of asylum seekers, to upend inhuman treatment of refugees and promote dignified life and treatment for people on the move.
<u>United African Women Organization (UAWO)</u>	20000	Greece	A grassroots, Black feminist collective founded and led by African and Black migrant women based in Athens, Greece. They host weekly assemblies which help plan campaigns for migrants' citizenship rights, they provide survivor-centred support against gender-based violence and they create spaces for healing and political education through storytelling and cultural events. With a community hub in the city, UAWO wants to strengthen intergenerational, migrant-led feminist power rooted in care and intersectional solidarity. The grant went into running a series of intergenerational, intercultural workshops to turn lived experience into shared advocacy and lasting collective power.
<u>Forensic Architecture Initiative Athens (FAIA)</u>	17000	Greece	A team of architects, artists, filmmakers, journalists, and engineers undertaking spatial and multimedia investigations to fight human rights violations and environmental violence, producing evidence to support affected communities in seeking justice. Their work has pivoted the way civil society can instrumentalise technology to build (and win) cases against unsurmountable forces like big corp and oppressive governments, using rational evidence to disarm corruption and buyouts. This grant supports their ongoing work centring on state and corporate violence.
<u>Egyenlő Esélyekkel az Iskolapadban Egyesület (Equal Opportunities in School Association): Deviszont Community Space</u>	20000	Hungary	A collective working with working-class and Roma youths in vocational schools on the outskirts of Budapest, building their knowledge of grassroots organising and laying the groundwork for citizen autonomy and long-term movement participation. This grant provides a continuation of core funding for the organisation.

<u>School of Public Life</u>	20000	<i>Hungary</i>	An education center for activists to exchange and learn about community organising and movement building in Budapest, Hungary. They support citizens dedicated to building a democratic and just Hungary, especially members of marginalized communities and those working on their behalf to organise themselves and stand up for their rights and interests effectively. This grant was given as emergency support to counter oppressive legislation in Hungary aiming to dissolve civil society organisations and prevent civic engagement.
<u>Kazán Community House (Alliance for Collaborative Real Estate Development)</u>	20000	<i>Hungary</i>	A grassroots hub in Budapest's 8th district hosting political education, media labs and movement gatherings for working-class and marginalised communities who live in the area. This grant went into core funding, campaigning and community outreach for their program "From Neighbourhood to Community" that invited impacted communities to come together and build shared resistance around the issues they have in common.
<u>SWAN - The Sex Workers' Rights Advocacy Network</u>	20000	<i>Hungary</i>	A sex-worker led regional network advocating for rights, safety, and well-being of sex workers in Central-Eastern Europe and Central Asia (CEECA). SWAN brings together 23 member organizations across 20 countries in the region, uniting groups that are either led by or work with sex workers. SWAN advocates for the decriminalization of sex work, access to health and social services, and the recognition of sex workers' human rights. This grant provides core funding, covering salaries and the continuation of their advocacy for decriminalisation and access to health and social services.
<u>Community Action Tenants Union (CATU) Ireland</u>	20000	<i>Ireland</i>	A member-funded tenants' union operating across the island of Ireland, committed to a community organising model built on collective action that goes beyond charity or service provision. They are functionally similar to a workplace trade union, except that their focus is on housing and community issues. They prevent illegal evictions, push for improved housing standards, win back unfairly held deposits and run larger campaigns around issues such as the need for a greater provision of public housing. This grant provides core funding for the organisation.

<u>Movimento Migranti e Rifugiati Napoli</u>	20000	Italy	A migrant-led movement in Naples that holds monthly decision-making assemblies to support migrants and refugees in their fight for dignified life. With this grant specifically, they aim to expand access to legal, educational, health, and housing support for migrant communities and want to enhance their capacity to organize national mobilizations, advocacy campaigns and develop programs for women, children, and other historically marginalised groups. This grant provides core funding to the organisation at their 10-year anniversary mark (congrats!)
<u>Porco Rosso</u>	20000	Italy	An anti-fascist, ecological, transfeminist, and anti-racist community space and collective laboratory based in Palermo, Sicily. Since 2016, its flagship "Sans-Papiers" project has provided weekly drop-in social and legal support for migrants and local residents facing precarious situations. They also carry out monitoring projects on migrant reception conditions and the criminalisation of boat captains. Porco Rosso is deeply embedded in local neighbourhood organising and creating networks, committed to forming communities and political movements built on trust and defending the rights of everyone. This grant provided a continuation of their activities via core funding.
<u>Sale Docks</u>	20000	Italy	A squatted cultural and social centre in Venice, Italy, occupied in 2007 by activists who wanted to challenge the role of art vis-à-vis gentrification and create a space for political resistance in a city dominated by tourism and private art institutions. Sale Docks is run by a horizontal collective of volunteers who host grassroots movements such as the No Grandi Navi committee fighting cruise ships, the Biennialocene assembly for art workers' rights, and Art Not Genocide Alliance, which campaigned against the Israeli Pavilion at the Venice Biennale. It supports local struggles against extractivism, advocating for precarious cultural workers, and building solidarity networks that connect Venice with global movements. This grant provided a continuation of their activities via core funding.

<u>Migrants and Refugees Movement of Caserta ODV</u>	20000	<i>Italy</i>	A movement born in 2002 from anti-racist organising in Caserta, composed of Italian activists and migrants and refugees from the province, fighting for migrant rights through assemblies, campaigns, and public demonstrations. This grant supports a large-scale information campaign reaching communities through social media, outreach, house-to-house meetings, and workplace organising.
<u>Gegužės 1-osios profesinė sąjunga - G1PS</u>	20000	<i>Lithuania</i>	A progressive grassroots labour and feminist union in Lithuania taking political action to promote workplace democracy, sustainable economy and solidarity, with a particular focus on precarious and migrant workers in sectors with no union representation and thus more prone to rights violations. With this grant they aim to: train local labour law consultants and union organisers, coordinate a Platform Workers' Union that can get gig work recognised as labour, establish a foreigners branch in G1PS and start a proper campaign against xenophobia in the workplace and finally, monitor the current restrictive law on strikes changes in Lithuania.
<u>Trans Autonomija</u>	20000	<i>Lithuania</i>	A trans-rights organisation in Vilnius founded in 2019, ensuring trans voices lead policy and public narrative work while centring the most marginalised: trans femmes, trans migrants, trans people with disabilities, and trans youth. This grant provides core funding for their advocacy, community building, and human rights monitoring work.
<u>Association for climate and social justice Kolektiv Zet Skopje (Balkan Commons Network)</u>	20000	<i>Macedonia</i>	A network building collective resistance across the Balkans by connecting climate justice and ecology with other social movement struggles, making sure that local struggles are linked for translocal and transnational action. They facilitate skill-sharing and capacity building with movements in the region while also bringing climate justice and ecology perspectives into the agenda of grassroots movements. This grant supports the organisation of their annual gathering and the continued development of the network.

<u>TransFormA</u>	15000	<i>Macedonia</i>	The first and only initiative in North Macedonia working on the protection and promotion of the rights of transgender people, led by the transgender community itself. Their work on community visibility and protection of individuals, better accessibility to social, legal and healthcare systems and advocacy to ensure proper regulation of transition medical procedures. This grant provided a continuation of their activities via core funding.
<u>Queer Montenegro</u>	20000	<i>Montenegro</i>	Feminist, queer, and sapphic-led, Queer Montenegro is dismantling the patriarchal and heteronormative machinery one front at a time, through public advocacy, policy lobbying, and international solidarity. They are among the principal architects of Montenegro Pride, an event that is celebration and confrontation in equal measure: a collective refusal to be silenced in a context where queer visibility is still met with hostility. Their work insists that emancipation is not a request, but a demand. This grant provided a continuation of their activities via core funding.
<u>Maruf Foundation / Stichting Maruf</u>	20000	<i>Netherlands</i>	A long standing international platform uplifting queer muslim experiences, Maruf provides safe, supportive spaces for queer Muslims to connect, grow, and access professional development while training professionals to better support queer Muslims across sectors like education and healthcare. This grant supported their Queer Muslim Voyager programme, a translocal leadership development initiative designed for queer Muslims across Europe. It supports current and emerging community leaders in cultivating sustainable, community-rooted leadership in the face of systemic injustices such as Islamophobia, queerphobia, racism and burnout.
<u>Syrian Volunteers Netherlands</u>	20000	<i>Netherlands</i>	A refugee-led grassroots organisation based in Amsterdam that brings together organisers, artists, researchers, and community builders with lived experience of displacement to build refugee-led power across Europe. What began as small volunteer initiatives has grown into a national and transnational network linking refugee-led and grassroots groups across Europe. They use their platform to challenge Fortress Europe by creating new infrastructures of belonging and solidarity rather than seeking integration into institutional systems.

<u>MiGreat</u>	20000	<i>Netherlands</i>	A grassroots organisation in Amsterdam by people who previously offered aid along the Balkan migration route, shifting from humanitarian work to root-cause action that challenges the European border regime. Largely composed of people with lived experience of migration, MiGreat runs workshops, a hotline and does direct actions such as flyer campaigns at airports and sending activists onto deportation flights to disrupt them, work that this grant helped happen. Their work combines practical resistance with public campaigning, social media outreach and election advocacy. MiGreat believes that borders are a form of passport apartheid and that change happens when ordinary people refuse to cooperate with the system.
<u>Global Energy Embargo for Palestine</u>	20000	<i>Palestinian Territories</i>	An international coalition responding to Palestinian trade unions' call to disrupt energy flows to and from Israel, running the 'No Harbour for Genocide' campaign targeting maritime supply chains of military equipment and energy to Israel. This grant provides campaigning funds in direct solidarity with the Palestinian call to
<u>Pomoc SOC</u>	20000	<i>Poland</i>	A solidarity organisation supporting people on the move in Poland through border violence monitoring, material aid, legal support, and campaigning against racism and rising xenophobia. This grant provides core funding to build the team supporting this work and create a fund for emergency response resilience.
<u>Stowarzyszenie Przy Pulaskiego (Rozbrat)</u>	20000	<i>Poland</i>	Active for 30 years now, Rozbrat is the oldest social centre in Central-Eastern Europe serving as a key infrastructure hub for intersectional struggles across housing, anti-racism, workers' rights, the environment, and feminism in Poznan and beyond. This grant provides core funding for the group as they fight against eviction and privatisation of their space.
<u>NOMADA (Polish Palestinian Justice Initiative Kaktus)</u>	20000	<i>Poland</i>	A Palestinian-led initiative founded by a team of Polish, Palestinian, and Polish Jewish women with decades of experience in social justice, anti-capitalist, and international solidarity activism. Their work covers strategic litigation such as filing legal complaints against Israeli officials for war crimes, challenging Polish arms trade complicity, and combating Islamophobic hate speech. They also provide material, legal, and psychological support to Palestinian evacuees in Poland, with a trauma-informed, intersectional approach that centres the voices and agency of survivors. This grant provides core funding for this work to continue.

<u>Jornal Mapa / Media campaign (Covas do Barroso)</u>	20000	<i>Portugal</i>	An independent media campaign by journalists and activists covering local resistance movements against socio-ecological violations in Portugal. This grant funds media production, film screenings, and debates to raise awareness of anti-extractivist struggles, strengthen affected communities, and drive broader social mobilisation.
<u>Associação Unidos em Defesa de Covas do Barroso (UDCB)</u>	20000	<i>Portugal</i>	Frontline defenders standing against Europe's largest lithium mine in Barroso, Northern Portugal, fighting to protect their territory and communities from the destruction wrought by big-mining, state complicity, and multinational lobbying. This grant provides core funding for their annual Climate Justice Camp.
<u>Roma feminist collective</u>	20000	<i>Romania</i>	A transnational, interdisciplinary network of Roma women created in response to the systemic marginalization and exclusion of Roma women in the labor market, decision-making spaces, and academia—both within feminist and anti-racist movements and the broader Roma advocacy landscape. Grounded in feminist, anti-racist, and intersectional principles, they aim to dismantle structural inequalities and elevate the voices, leadership, and expertise of Roma women and girls globally. This grant provides core funding for the group.
<u>A.casa Cluj Social Center / Asociatia Spatiu 161</u>	20000	<i>Romania</i>	A radical autonomous community space in Cluj hosting informal political groups who share principles of horizontal organising, anti-capitalism, solidarity, and mutual care. This grant provides core funding for the renovation and maintenance of the space so it can continue to serve the movements that call it home.
<u>UG Ne dam Nu dau</u>	20000	<i>Serbia</i>	A dedicated group of active citizens in Serbia working to motivate people to take an active role in shaping their community through public discussions, awareness campaigns, and civic participation initiatives, work that is particularly important in the context of governmental crackdown and corruption as in Serbia. This grant supports their organising work ahead of the upcoming local elections in the region.

<u>Kolektiv Talas TIRV</u>	20000	<i>Serbia</i>	Collective of trans and non-binary activists that address the problems of the TIGV (trans, intersex and gender variant) community in Serbia with a broader intersectional-feminist approach. They are implementing educational, community-building and -support programs in order to empower young community members to engage in activism and stand up for themselves. This grant provides
<u>Klara i Rosa</u>	20000	<i>Serbia</i>	An organisation in Subotica, northern Serbia, working to bring together a polarised multi-ethnic city through cultural programmes and critical education that help people blend beyond perceived difference, fostering dialogue and civic participation in a neglected part of the country. This grant supports their programmatic activities,
<u>Libergraf</u>	20000	<i>Serbia</i>	A civil society organisation founded in 1998 by youth activists in Užice, working across youth inclusion, education, urbanism, alternative culture, environmental protection and anti-extractivism against fascist and corrupt forces in western Serbia. This grant provides core funding for the organisation.
<u>ZBOR</u>	20000	<i>Serbia</i>	An informal, grassroots Balkan network of activists, land defenders, and communities resisting harmful mining and the so-called "green transition" they see as colonial resource extraction in disguise, organising through open assemblies, camps, and permanent protest hubs. This grant provides core funding for their work building a broad movement for justice across the region.
<u>CK13</u>	20000	<i>Serbia</i>	An independent social and cultural centre in Novi Sad active for 17 years, building political self-consciousness and igniting the appetite for self-organisation among local youth through political, activist, educational, and cultural program initiatives. This grant provides core funding for the organisation.

<u>Association of the Independent Cultural Scene of Serbia (Magacin Cultural Centre)</u>	20000	<i>Serbia</i>	A cultural and social center that functions as a commons in Belgrade. Because it is a commons, it is a resource managed by the community of users (its assembly) according to the commonly established community guidelines. They create varied programs around arts and culture and serve as a social movement hotspot and convergence space. The space operates on voluntary work from all the users who are driven by the ideas of commoning, social diversity, mutual cooperation, solidarity and tolerance, mutual trust and responsibility.

The work is economic in the deepest sense, not about inclusion in markets, but about building the infrastructures that make alternative livelihoods and relationships durable. This grant provides core funding for the organisation.

<u>Revoltes de la Terra</u>	7500	<i>Spain</i>	A climate and environmental justice movement born from gatherings in defence of the territories of the Països Catalans, bringing together diverse struggles to defend land and dignified life against ecocide, industrialisation, and the destruction of territory. Through their work, not only do they highlight the climate calamities that are felt on the ground, but also who is suffering most. This grant provides urgent funding for their first direct action.
<u>ZeroPort</u>	9000	<i>Spain</i>	A platform that leads the against aviation and increased emissions movement for the degrowth of Barcelona's port and airport. It aims to halt new developments of fossil fuel transport infrastructure while advocating for the need to degrow in material flows and pollution. Zeroport was established following a meeting on the degrowth of aviation, organised in collaboration with Stay Grounded - a previous Guerrilla grantee. Initially, 30 organisations were part of Zeroport, but now the platform has grown to include 150 collectives who all stand behind its mission. The funding went into reactivating the struggle against the new proposed expansion of Barcelona airport.
<u>Olivia Linander (Sámi grassroots gathering)</u>	5000	<i>Sweden</i>	A gathering bringing together indigenous rights and land defenders who organise from across Sápmi and beyond for a weekend in Jokkmokk to reconnect and re-energise the indigenous communities of the northern countries. The most pressing political issue for the gathering centers around community agency over the territories that are at risk of being removed by government and corporate power. This grant supports the organisation of Sámi Grassroots 2025.
<u>Coordination Climat Justice Sociale</u>	9000	<i>Switzerland</i>	A small collective that has partnered with more than 20 indigenous movements and grassroots organisations from five continents to help them defend their territories against fossil fuel projects through civil disobedience, mobilisations, and solidarity tours. This grant supports indigenous leaders from four Amazonian countries to travel to Europe and protest at the general assemblies of European banks financing deforestation and fossil fuel extraction in their territories.

<u>Medya ve Göç Derneği</u> (Media and Migration Association)	9000	Turkey	An independent organisation in Turkey committed to pluralist, rights-based media on migration conducting media monitoring, fighting disinformation and hate speech and building counter-narratives to a sensationalist and conservative media landscape. This grant supported the tailoring of their advocacy strategy towards young prospective journalists and researchers in migration reporting.
<u>Mültecilerle Dayanışma Derneği</u> (Association for Solidarity with Refugees)	9000	Turkey	A grassroots, rights-based organisation in Izmir challenging systemic violations in Turkey's asylum system including arbitrary detention, unlawful deportations, and barriers to protection. They do this through legal counselling, monitoring of removal centres and strategic litigation. This grant contributed to the group's ability to document systemic rights violations in Türkiye's asylum and detention system and use the harvested evidence to challenge arbitrary detention, unlawful deportations and barriers to international and temporary protection.
<u>PARISC</u> (Pan-African Reparations Internationalist Standing Conference)	9000	United Kingdom	A UK-based organisation working to harmonise grassroots reparatory justice efforts for communities affected by enslavement and colonialism, drawing direct lines between past imperialism and present-day injustice. This grant supported their internationalist forum in Berlin, convened to mark 140 years since the 1884 Berlin Conference that carved up the African continent.
<u>Red Flare</u>	9000	United Kingdom	A volunteer group of anti-fascist investigators in the UK using open-source and investigative methods to expose far-right groups, sharing findings with journalists, threatened communities, and those organising against the far right. This grant provides core support for the organisation.
